Hold Harmless Agreement

This agreement is between the Borough of New Milford and the applicant as stated in the Borough of New Milford Recreation Commission Field Use Application.

WITNESSETH:

1. In consideration of permission to use the Borough of New Milford Recreation Facility on the dates, times and locations as approved in the preceding application, the applicant does hereby covenant and agree to save and hold harmless the Borough of New Milford, its agents, servants, employees, elected officials, volunteers and appointees from any and all liabilities or costs arising out of the use of the recreation facility by the applicant, the applicant's invitees, or other persons.

2. The applicant has furnished a Certificate of Insurance, naming the Borough of New Milford as additionally insured, described below as an additional inducement to the permission for use of the park, a true copy of which is annexed hereto.

Page 2: Borough of New Milford – Hold Harmless Agreement

5. The applicant acknowledges that the permission to utilize the park is limited to the portion of the recreation facility herein described (if applicable) and is valid only for the activity herein described. Notwithstanding the foregoing, however, the Hold Harmless Agreement shall be applicable to any Claim asserted against the Borough of New Milford or any loss incurred arising out of the applicant’s activity, whether or not the same extends beyond the permitted type or locale of activity or occurs on a different date than specified.

6. The applicant specifically agrees that this indemnification and Hold Harmless Agreement shall include the responsibility to provide legal defense for the Borough of New Milford for any suit arising out of the applicant’s use of the recreation facility, and that, should the applicant or the applicant’s insurance carrier fail or refuse to provide such a defense, the applicant will reimburse the Borough of New Milford for any costs incurred by it for any person or organization acting on its behalf.

Rules and regulations governing the use of parks and play-grounds in the Borough shall be as follows:

- No person shall cut, injure, deface, remove or disturb any tree, shrub, building, fence, bench or other structure, apparatus or property, or pick, cut, or remove any shrub, bush, or flower; or mark or write upon any building, fence, bench or other structure; or throw empty cans, bottles or other refuse or debris; or create a dangerous or hazardous condition.
- No person shall make or kindle an open fire except in a grill.
- No animals shall be led in parks unless leashed, or be permitted to run at large.
- No person, unless authorized by law, shall carry fire-arms of any description or any other weapons set forth in N.J.S.A. 2C:39-4, or throw stones or other missiles.
- No person shall sell, offer or solicit for sale any goods or merchandise without permission from the Recreation Commission.
- No person shall consume, use, carry or bring any alcoholic beverage in any form in or upon any park without a permit.
- No person may use or remain in a public park between the hours of sunset and sunrise, except where posted. Borough parks located at Kennedy Memorial Park are to be closed to the public at 11:00 p.m. from April 15 to August 15; and from August 16 to April 14, the park is to be closed at 10:00 p.m., except where otherwise authorized by the Recreation Commission.
- No person without authorization of the Recreation Commission shall distribute any circulars, cards or written matter or post, paste, or affix any placard, notice or sign within the parks.
 - No entertainment or exhibition shall be given in any park except under the direction or by permission of the Recreation Commission.
- It shall be unlawful for any person to enter upon any portion of parks and recreation facilities or grounds, in disregard of signs, or posted notices forbidding the same.
- Playing baseball, football or other sports is prohibited except in areas expressly set aside for these activities.
- Smoking upon any public parks and recreation facilities or grounds is prohibited.
